General

In pursuance to the decisions of the Apex Court in Islamic Academic Educational and Another Vs. State of Karnataka and others dated 14.08.2003, a Common Entrance Test is to be conducted. Sri Balaji Vidyapeeth (SBV) Deemed to be University will be conducting Common Entrance Test for the purpose of admitting students to B.Sc. (NURSING) / P.B.B.Sc (NURSING) / M.Sc. (NURSING) / NPCC (Interview Only) / B.Pharm programmes offered at Kasturba Gandhi Nursing College, a constituent teaching unit of SBV, B.Sc(N) programme at Shri Sathya Sai College of Nursing, SSSMCRI Campus, Chennai and B.Pharm at School of Pharmacy, SBV Campus, Pondicherry.

The application is meant for registering the candidate for Common Entrance Test on all India Basis B.Sc.(N)/P.B.B.Sc.(N)/M.Sc.(N) NPCC (Interview Only) / B.Pharm-2023 conducted by SRI BALAJI VIDYAPEETH-Deemed to be University, for KASTURBA GANDHI NURSING COLLEGE, SBV Campus, Pillaiyarkuppam, Pondicherry – 607402, SHRI SATHYA SAI COLLEGE OF NURSING, SSSMCRI Campus, Chennai and SCHOOL OF PHARMACY, SBV Campus, Pondicherry.

Eligibility for Admission

As per the pre requisite for admission to Nursing / B.Pharm programmes, candidates must have appeared in SBVDUCET - 2023. However, mere appearance in SBVDUCET-2023 will not automatically essentially entitle a candidate for admission to Nursing / B.Pharm programme. For admission, the candidate should fulfill the admission requirements as prescribed by the Indian Nursing Council, Pharmacy Council of India and Sri Balaji Vidyapeeth, Deemed to be University.

Post Basic B.Sc.(N) (40 Seats)

Candidates should have:

- Passed the Higher Secondary or Senior Secondary or Intermediate or 10+2 or an equivalent examination recognized by the university for this purpose. Those who have done 10+1 in or before 1986, will be eligible for admission.
- Obtained a certificate in General Nursing and Midwifery and registered as R.N.R.M. with the State Nurses Registration Council. A male nurse, trained before the implementation of the new integrated course besides being registered as a nurse with State Nurses Registration Council, shall produce evidence of training approved by Indian Nursing Council for a similar duration in lieu of midwifery in any one of the following areas:
 - O.T. Techniques
 - Ophthalmic Nursing
 - Leprosy Nursing
 - TB Nursing
 - Psychiatric Nursing
- Neurological and Neuro Surgical Nursing
- Community Health Nursing
- Cancer Nursing
- Orthopedic Nursing

B.Sc. (Nursing) (100 Seats + 8 Seats under supernumery Quota)

- A candidate should have passed in the subjects of Physics, Chemistry, Biology (PCB) and English individually and must have obtained a minimum of 45% marks taken together in PCB at the qualifying examination (10+2) from recognized board under AISSCE/CBSE/ICSE/SSCE/HSCE or other equivalent Board.
- Students appearing in 10+2 examination in Science conducted by National Institute of Open School with 45% marks.
- 5% of marks is relaxed for SC/ST candidates.

M.Sc. (Nursing) (25 Seats)

- The candidate should be a Registered Nurse and Registered Midwife or equivalent with any State Nursing Registration Council.
- The minimum education requirements shall be the passing of B.Sc. (Nursing)/Post Basic B.Sc. (Nursing) with a minimum of 55% aggregate marks.
- The candidate should have undergone B.Sc. (Nursing)/Post Basic B.Sc. (Nursing) in an institution which is recognized by the Indian Nursing Council.
- Minimum one year of work experience after registration of Basic B.Sc. (Nursing). with State Council
- Minimum one year of work experience prior or after Post Basic B.Sc. (Nursing). after registration with the Council

M.Sc. Nursing Course Specialization

M.Sc. Nursing programme is offered in the following specialization with Five Seats in each.

- 1. Medical and Surgical Nursing
- 2. Child Health Nursing
- 3. Community Health Nursing
- 4. Psychiatric Nursing / Mental Health Nursing
- 5. Obstetric and Gynaecology Nursing

Master's Level Nursing Practitioner in Critical Care (M.Sc. (N) - NPCC) (10 Seats)

- NPCC is post graduate Residency programme
- Applicants must possess a registered B.Sc Nurse with a minimum of one year clinical experience, preferably in any critical care setting, prior to enrollment.
- Must have undergone B.Sc(N) in an institution recognised by Indian Nursing Council (INC)
- Must have scored not less than 55% aggregate marks in B.Sc(N) program.

B. Pharm (60 Seats)

The Candidate seeking for admission to the first year B.Pharm should have passed in Higher Secondary Examination with a minimum of 50% aggregate in English, Physics, Chemistry & Mathematics or English, Physics, Chemistry and Biology (or) English, Physics, Chemistry, Biology and Mathematics as subjects.

Age Limit

B.Sc. (Nursing) : The candidate should be 17 years of age and above on

31st December 2023. No upper age limit is prescribed.

P.B. B.Sc. (Nursing)/
M.Sc. (Nursing)/NPCC : No age limit is prescribed.

B. Pharm : The candidate should be completing 17 years of age and above on

31st December 2023. Upper age limit is 35 years.
